Video Surveillance System Data Protection Notice

I. Introduction

OVIK Health is committed to Processing Personal Data responsibly and in compliance with the applicable data protection laws in all countries in which OVIK Health operates. Please refer to our website for further details on our overall data protection principles and privacy notices.

This Video Surveillance System Data Protection Notice (the "Notice") applies to Personal Data that OVIK Health, LLC and its affiliated entities ("OVIK Health" or the "Company") collect and process through video surveillance systems.

Respecting privacy is fundamental to our relationship with our current, former and future/potential employees, as well as with all persons visiting and/or working within OVIK Health's premises (such as, but not limited to, visitors, independent contractors, directors, interns, advisors, temporary workers, service providers, clients, etc.).

The purpose of this Notice is to give you information about (i) the installation of video surveillance within OVIK Health's premises, (ii) what Personal Data OVIK Health collects as a result of this video surveillance, (iii) how OVIK Health uses, shares, transfers and discloses this Personal Data and why, (iv) how long your Personal Data is retained, (v) what your rights are and how to submit privacy and data protection inquiries and complaints, and (iv) which OVIK Health legal entity is responsible for compliance.

II. Cameras on OVIK Health's sites

OVIK Health operates a video surveillance system at its various sites. The cameras are generally located around the perimeter of the sites and at various appropriate locations around the site itself.

Certain cameras may be located where all members of the public may be captured within the footage. Specific signage or notices are placed at the entrance of the premises under surveillance and at suitable locations around the site.

III. What Personal Data We Collect, Use, Transfer And Disclose, And Why

Through the use of video surveillance, OVIK Health will collect the following information about you:

- Visual information which allows identification of those in the camera's area of coverage at a particular time ("Personal Data").
- OVIK Health does not collect and process sound recordings.

OVIK Health collects and processes the Personal Data in accordance with applicable data protection laws and only (i) for specified legitimate interests, (ii) to protect your interests or (iii) to comply with its legal obligations.

OVIK Health processes Personal Data for the following purposes and on the following legal basis:

• **Health and safety**: (i) to maintain and develop a safe working environment, (ii) to ensure the safety and security of the persons within OVIK Health's premises, (iii) to protect the health and

safety of employees and others working within OVIK Health's premises, (iv) the deterrence against and detection of any appropriate conduct at the work place, and (v) to monitor bulk deliveries and/or offloading of potentially hazardous materials in accordance with legal obligations.

- Protection of the equipment, goods, and property of the company: (i) the deterrence against unlawful or unauthorized entry to OVIK Health's premises, (ii) the prevention against theft, burglary and fire, (iii) the deterrence against unlawful acts being committed within OVIK Health's premises, and (iv) to ensure that there are no breaches of confidentiality through removal of within OVIK Health's property from the Premises.
- Control of the production process with regard to the machinery: to ensure the proper functioning of the machinery.
- Control of the production process with regard to the employees: to evaluate and improve the work organization and performance of employees.
- Investigations and legal procedures, to the extent allowed by applicable law: (i) to conduct investigations and manage internal complaints or claims, (ii) to pursue legal rights and remedies and (iii) to defend or institute legal claims.

The video surveillance within OVIK Health's premises is permanent for the purposes identified above to the extent allowed by applicable law.

OVIK Health will not use the Personal Data collected from video surveillance for any other purpose incompatible with the purposes described in this Notice, unless it is required or authorized by law, authorized by you, or is in your own vital interest (e.g., in the case of a medical emergency).

The video surveillance does not aim to collect special or sensitive categories of data, such as racial or ethnic origin, political opinions, religious or philosophical beliefs, trade union membership, or data concerning health or sexual orientation.

IV. Use and Transfer of Personal Data

OVIK Health will only grant access to Personal Data on a need-to-know basis and only for the purposes described in this Notice. This may include OVIK Health senior managers and their designees, personnel in HR, IT, Compliance and Legal.

We may transfer the Personal Data outside the jurisdiction in which it was collected, for example to OVIK Health and/or to its global affiliates. We only transfer your Personal Data in this way in order to protect our legitimate interests and your interests for any of the purposes indicated above, or to comply with legal obligations.

Such transfers will only take place to the extent necessary for these purposes and may include third parties such as service providers to facilitate or monitor the surveillance systems, or as required by applicable law.

OVIK Health will ensure that when Personal Data is transferred to countries that have different standards of data protection, appropriate safeguards to adequately protect the Personal Data are implemented to secure such data transfers in compliance with applicable data protection laws. Where applicable, the Company has implemented international data transfer agreements in order to provide appropriate and suitable safeguards for Personal Data being transferred to countries outside your jurisdiction where an adequate level of protection is not already guaranteed.

V. Data Security

OVIK Health is committed to maintaining the confidentiality, integrity, security, and resilience of your Personal Data. To this effect, OVIK Health has implemented appropriate technical and organizational measures to protect Personal Data that are consistent with applicable data protection and privacy laws and regulations, including requiring our service providers to use appropriate measures to protect the confidentiality and security of Personal Data.

OVIK Health has developed various security policies and procedures to protect the data collected. These policies and procedures are available upon request from the Global Privacy Director at privacy@milliken.com.

VI. Data Integrity and Retention

OVIK Health will take steps to ensure that the Personal Data processed is reliable for its intended use and is accurate and complete for carrying out the purposes described in this Notice.

OVIK Health will not retain your Personal Data processed longer than allowed under the applicable data protection laws and, in any case, no longer than such Personal Data is necessary for the purposes for which it was collected or otherwise processed, subject to applicable local retention requirements. Standard retention periods will be 30 days (maximum of 1 year) unless shorter retention periods are applicable under local law. Some data may be extracted for further analysis in connection with a legal claim or investigation and therefore may be kept for a longer period. In such cases, the extracted data will be kept for as long as necessary in the context of legal claims.

VII. Data Protection Rights

Under applicable data protection laws, you will benefit from the following rights. You can exercise these rights at any time by contacting the Global Privacy Director:

- Right to access to, rectification and erasure of Personal Information;
- Right to restriction of Processing;
- Right to object to Processing;
- Right of data portability to the extent applicable;
- Right to withdraw consent where the Processing is based on consent; and
- Right to lodge a complaint with the relevant supervisory authority.

VIII. Miscellaneous

This Notice shall be effective as of 1 November 2023 and shall be applicable to all OVIK Health entities. This Notice may be revised and amended from time to time and appropriate notice about any amendments will be given.

OVIK Health is also allowed to adapt the text of this Notice in order to be compliant with local legislation by means of an addendum attached to this Notice. In case of any discrepancies between this Notice and a specific local addendum made in accordance with local law, the terms of the latter shall prevail.
